# Data Privacy Notice St James the Great, Stonesfield

#### 1. Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation 2016/679 (the "GDPR") and the Data Protection Act 2018, (the "DPA 2018").

#### 2. Who are we?

This Privacy Notice is provided to you by the Parochial Church Council (PCC) of St James the Great, Stonesfield. The PCC works together with the incumbent of the parish (that is, our Rector).

As the church is made up of PCC, clergy, ministers, together with associated lay volunteers and administrators all working together, we may need to share personal data we hold with them, so that they can carry out their responsibilities to the Church and our communities. The PCC and incumbent referred to above are joint data controllers (this means they decide how your personal data is processed and for what purposes), which means we are all responsible for how we process your data.

In the rest of this Privacy Notice, we use the word "we" to refer to any or all of the above data controllers, as appropriate.

## 3. How do we process your personal data?

The PCC and incumbent comply with their obligations under the GDPR and DPA 2018 by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We use your personal data for the following purposes:

- To enable us to meet all legal and statutory obligations (which include maintaining and publishing our Electoral Roll in accordance with the Church Representation Rules).
- To minister to you and provide you with pastoral and spiritual care (such as visiting you when you are gravely ill or bereaved) and to organise and perform services for you, such as baptisms, confirmations, weddings and funerals.
- To deliver the Church's mission to our community and to carry out any other voluntary or charitable activities for the benefit of the public in the parish.
- To administer membership records and carry out DBS checks where necessary
- To manage our employees and volunteers
- To fundraise and promote the interests of the Church.
- To maintain our own accounts and records and to process any donations that you have made to us (including the processing of Gift Aid information).
- To inform you of news, events, activities and services running at St James the Great
- To carry out safeguarding procedures in accordance with best safeguarding practice
- To share your contact details, when necessary, with the Oxford Diocesan Board of Finance which is responsible for the financial and administrative arrangements for the Diocese of Oxford, including the granting of faculty permission for building repairs and maintenance.

### 4. What is the legal basis for processing your personal data?

The legal basis for processing varies depending on the purpose:

- Most of our data is processed because it is necessary for our legitimate interests, or the
  legitimate interests of a third party (such as the Oxford Diocesan Board of Finance). An
  example of this would be holding office-holder's personal data to support the day-today communications needed to run our churches (this applies to roles such as
  churchwarden and PCC Secretary). We will always take into account your interests,
  rights and freedoms.
- Some of our processing is necessary for compliance with a **legal obligation**. For example, we are required by the Church Representation Rules to administer and publish the Electoral Roll, and under Canon Law to announce forthcoming weddings by means of the publication of banns.
- We may also process data if it is necessary for the performance of a contract with you, or to take steps to enter into a contract. An example of this would be processing your data in connection with a contract for maintenance of our buildings or equipment, or hire of the church hall.
- For other purposes we will process your data with your explicit **consent**. An example of this would be regular email newsletters providing information about our services and activities in the parish.

#### 5. Sharing your personal data

Your personal data will be treated as strictly confidential and will only be shared with church members and the Rector, or anyone acting in his/her capacity, in order to carry out a service to other church members or for purposes connected with the church. It will only be shared with third parties outside of the parish with your consent.

#### 6. How long do we keep your personal data?

We keep data in accordance with the guidance set out in the guide "Keep or Bin: Care of Your Parish Records" which is available from the Church of England website<sup>1</sup>. Specifically, we retain Electoral Roll data while it is still current<sup>2</sup>; Gift Aid declarations and associated paperwork for up to 6 years after the calendar year to which they relate; and parish registers (baptisms, marriages, funerals) permanently.

We will keep some records permanently if we are legally required to do so. In general, we will endeavour to keep data only for as long as we need it. This means that we may delete or destroy it when it is no longer needed.

### 7. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data:

- The right to request a copy of your personal data which the PCC holds about you;
- The right to request that the PCC corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for the PCC to retain such data;
- The right to withdraw your consent to the processing at any time;

- The right to request that the data controllers provide you with your personal data and where possible, to transmit that data directly to another data controller, (known as the right to data portability), where applicable.
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data, where applicable.
- The right to lodge a complaint with the Information Commissioner's Office.

When exercising any of the rights listed above, in order to process your request, we may need to verify your identity for your security. In such cases we will need you to respond with proof of your identity before you can exercise these rights.

### 8. Further processing

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
